

RESOLUTION 2026-6

EDGEWATER PARK SEWERAGE AUTHORITY

RESOLUTION APPROVING CHANGE ORDER NUMBER 2 FOR THE PUMP STATION #3 UPGRADE CONTRACT IN AN AMOUNT NOT TO EXCEED TWELVE THOUSAND SEVEN HUNDRED SIX DOLLARS NINETY FOUR CENTS (\$12,706.94), FOR AN ADJUSTED TOTAL CONTRACT AMOUNT NOT TO EXCEED ONE MILLION EIGHT HUNDRED THIRTEEN THOUSAND FIVE HUNDRED FORTY-THREE DOLLARS NINETY FOUR CENTS(\$1,813,543.94)

WHEREAS, the Edgewater Park Sewerage Authority, a duly constituted public body in the County of Burlington, State of New Jersey (“Authority”);

WHEREAS, the Authority Engineer has received notice of a change order number 2, necessary to ensure proper position of a new generator pad to complete the upgrades to Pump Station #3 of the sanitary sewer system;

WHEREAS, the Authority has received a change order number 2, for Twelve Thousand Seven Hundred Six Dollars Ninety-Four Cents (\$12,706.94) for the upgrades to Pump Station #3 of the sanitary sewer system;

WHEREAS, the Authority’s Engineer has reviewed the change order and recommends approving change order number 2, for the upgrades to Pump Station #3 of the sanitary sewer system;

WHEREAS, the Authority desires to approve the Engineer’s recommendation to pay change order number 2, for the upgrades to Pump Station #3 of the sanitary sewer system for a total adjusted contract amount not to exceed One Million Eight Hundred Thirteen Thousand Five Hundred Forty-Three Dollars Ninety Four Cents (\$1,813,543.94);


NOW, THEREFORE BE IT RESOLVED, upon proper motion and vote at a public meeting by the Edgewater Park Sewerage Authority in the County of Burlington, State of New Jersey as follows:

1. Approving change order number 2 to the contract for the upgrades to Pump Station #3 of the sanitary sewer system in an amount not to exceed Twelve Thousand Seven Hundred Six Dollars Ninety Four Cents (12,706.94) for a total adjusted contract amount not to exceed One Million Eight Hundred Thirteen Thousand Five Hundred Forty-Three Dollars Ninety Four Cents (\$1,813,543.94) is hereby **ADOPTED** by this Resolution on January 14, 2026;


2. This approval shall be subject to certification of availability of funds to pay for this work.
